3. Self-attested copies of HS/Class XII Registration Certificate, Admit, Marks-Sheet and Certificate.
4. Self-attested copies of Certificate of Caste/PWD/Extra Curricular Activity/NCC/NSS (if any).
5. Self-attested copy of AADHAAR (self).
6. Self-attested copy of Front Page of Bank Passbook (self).
7. An Undertaking regarding data/information submitted by the student. (Undertaking format available in College Website)
8. Affidavit by the student and his/her parent on "Curbing the Menace of Ragging in HEI". (Affidavit format available in College Website)

GUIDELINES FOR AVAILING FEE WAIVER SCHEME

- Students whose parental annual income is less than Rs. 4 Lakh per annum from all sources will be eligible to avail this scheme.
- If either of the parent (mother or father) of the student is working in the State Govt./Central Govt./Semi Govt./State or Central Govt. undertakings, such students shall not be eligible under this scheme.

Particulars/Documents required for availing Fee Waiver Scheme: -

1. Ration Card of the student or his/her parent. In case the students or their parents don't have a Ration Card then a valid Annual Income Certificate (Less than Rs. 4 Lakh) of the parent is to be submitted. (In case of Fee Waiver Scheme availing by Ration Card, original Ration Card is to be produced before the Verification Desk.)
2. Declaration from the students that neither of parents (father or mother) of the student is an employee of State/Central Govt. Departments or its undertakings. (Declaration format available in College Website)

N.B.: All documents/testimonials are to be produced in original before the Verification Desk.

Students who are eligible for availing Fee Waiver scheme need not to pay any fees to the College for their admission. However, the students under APL category shall have to pay the actual Admission Fees as per the Admission Fee Structure.
